Position title: Community Swimming & Water Safety Officer

General Description

The Swimming Waikato, Community Swimming & Water Safety Officer is responsible for leading the development of Swimming and Water Safety initiatives in the Waikato. In doing so you will work with and through several of our current and potential LTS & WS providers, funders and supporters. This role will oversee and grow the capacity and delivery of Swimming Waikato's School Learn to Swim and Water Safety initiatives as well as supporting local club development throughout the region.

Duties and Responsibilities

- Increase the number of young people (5-18 years) actively participating in swimming and water safety activities.
- Grow the ability of local clubs and communities to provide quality swimming and water safety opportunities
- Increase the skills and confidence in young people to participate in swimming and water safety and be in and around water
- Assist with the development of teachers and coaches throughout the region.
- Working with our clubs and their teachers/coaches to establish a programme of long term
 planning with a view to promote and keeping young people involved with swimming
- Bridging the gap between local private and council learn to swim programmes with club swimming, to help young swimmers continue their swimming journey
- Maintaining an effective relationship with clubs, coaches' schools, teachers and volunteers
- Establish events and other activities that encourage participation in swimming and or water safety that promote further participation in swimming or alternative aquatic activities.
- Support the marketing and communication of valuable insights (e.g teacher surveys, provider consultations) and researched practice to make improvements in the provision of LTS & WS whilst promoting the many life long benefits of actively participating in swimming
- Ensure effective monitoring and evaluation methods are undertaken that demonstrates the impact of all work
- Contribute to the development of funding applications on behalf of Swimming Waikato as and when required

- Knowledge and understanding of the operating models in primary and intermediate schools
- Ability to use te reo Maori vocabulary
